

# Vape Recycling Facilities in the UK: Investment by Local Authorities





## Overview

This data was gathered by leading vape trade body, the UK Vaping Industry Association, through Freedom of Information Requests issued to major provincial UK cities and central London councils.

The research looks at investment in vape recycling facilities and services by local authorities, as well as efforts to educate end users about the correct disposal of their used devices. It follows the launch of the UKVIA's <u>Recycle-Vapes.co.uk</u> online information hub.

**Unless specified, all data refers to:** 10 Major Provincial UK Cities and 10 London Authorities

## **Key Findings**

Of the 20 major provincial city and central London councils to respond:

60%

at civic tips (Designated Collection Facilities) 10%

have introduced vape waste containers in public places (both in council-owned buildings)

### Around

1/3

do not offer vape waste disposal containers/ drop off points of any kind

One

has introduce or invested in kerbside/ household collection for vapes to date



have not undertaken activities to raise awareness amongst vapers about how to recycle their vapes



**Wandsworth Borough Council** has plans to introduce a network of small WEEE waste collection bins with funding support from non-profit Material Focus.

However, the 'likely' service provider has advised the council shouldn't encourage residents to use these to recycle vapes. 40%

said they were using information on the council website to raise awareness amongst vapers on how to recycle their vapes

80%

have no plans to invest in new vape collection solutions in the next 12 months

## 30%

said they have used social media to raise awareness amongst vapers on how to recycle their vapes
